Key Changes Made by the ASU Hybrid Tax Regimes ASU 2019-12 amends the requirements related to the accounting for "hybrid" tax regimes Such regimes are tax jurisdictions that impose the greater of two taxes — one based on income or one based on items other than income Although ASC 740 does not apply to taxes based on items other than income, ASC 740-10-15-4(a) originally specified
